MESSAGE FROM DAN DEVENPORT

Our office has received the following guidelines from state Master Gardener Coordinator, Dr. Sara Shields, regarding future Master Gardener activities. These guidelines are subject to change at anytime based on the Governor's decision and the LSU AgCenter's directives.

It is our responsibility to make sure that each of us do our part as we work together in a gradual, staged reopening process focused on the health of our everyone. Everyone has a role to play in limiting the spread of the virus and keeping our health care system from becoming overwhelmed.

Volunteer guidelines for activity include:

- Remain at home if you are not feeling well or have a fever.
- Governor's guidelines for individuals 65 and older or with compromised immune systems say "safer at home" in Phases 1 and 2.
- Groups meeting indoors are limited to 25 individuals, with sanitation and social distancing
 measures implemented for the safety of all. Volunteer organization or individuals to supply
 sanitization and cleaning products to be used for events.
- Groups working outdoors together or receiving instructions should be 25 or fewer people, all spaced 6 feet apart or more.
- Volunteers may work individually, keeping 6 feet or more apart from others in the garden.
- Encourage use of face masks or other personal protective devices as a way of decreasing transmission rates.
- Hosts and participants should wear face coverings, with participants expected to provide their own personal protective equipment (PPE).
- Frequently clean high-touch areas, including door handles, restroom surfaces, handrails, tools, etc. Individuals should be encouraged to bring and use their own gardening tools and equipment; shared tools and equipment should be cleaned after each use. It is recommended that no food be served.
- Plant sales activities should consider online ordering and offering curbside pickup. Doing so limits the number of individuals (volunteers and customers) in any one area.
- Actively monitor where COVID-19 is circulating. Advise participants in advance that if they
 have any symptoms or feel unwell, they should not attend.

The specific plan of action that will need to be followed for us to move forward as an organization in our activities is detailed below. Activities will need to get a prior approval by the Lafayette Master Gardener Board and the LSU AgCenter Administration, before it can take place. A spreadsheet is being created to begin in July and likewise subsequent months afterwards that will record requests for activity with the following information needed:

ii. Reoccurrence of event

iii. Time

iv. Event Coordinator

v. Cell contact

vi. Email address

vii. Name of Meeting

viii. Number of participants

ix. Location

COVID-19 REOPENING CONTINUED

Committee chairs must submit a request for an approval of an activity/event by sending an email request with all of the above information to Colette Anzalone Colette.anzalone1@louisiana.edu. Once Colette receives the request, she will record it in a spreadsheet and the event will need approval from the board and our administration before can be advertised.

Any meeting that is being conducted under the name of the LSU AgCenter needs to be included and <u>approved for liability</u> coverage of the event!

Prior approval of activity/each event will also be required for *each* event! This prior approval will have a minimal two week in advance notice of the event. It should be submitted by Friday two weeks prior in advance. Three to four weeks notification is recommended to have time to notify members by appointment.

Once an event is approved, the event coordinator will receive the log sheets from Colette Anzalone that members <u>must</u> complete for that event. Traceability is the reason for this step and that we are strictly following the capacity requirements. Completed log sheets should be sent to Patrcia Soileau at pbsgardens@aol.com and a copy to me, Dan Devenport ddeven-port@agcenter.lsu.edu within a week following the event.

The Covid-19 pre-screening questions included on the log sheet that members will verify as a participate and answer NO to are as follows in order to participate are as follows:

- Have you, or anyone in your home, had close exposure to a person confirmed or under investigation for COVID-19, or someone with a respiratory illness within the past 14 days? Close contact for exposures is defined as being within approximately 6 feet of a person (without the proper PPE) suspected or confirmed with a case of COVID-19 for greater than 15 minutes.
- 2. Do you currently have respiratory symptoms such as a cough or shortness of breath/difficulty breathing, or at least two of the following: fever chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell?
- 3. Have you traveled internationally within the last 14 days?

Please note that meetings using virtual technology may still be the best option at this time and Charles Hebert and I do not mind assisting.

Social distancing Guidelines MUST be followed and enforced. Please realize that the entire program could be shut down, if procedures are not enforced. The LPMGA Board, UL Lafayette Staff and/or LSU AgCenter Staff has full oversight of monitoring approved activities.

Your health and safety are our top priority as we move forward with this process. We continue to be inspired by your dedication and resilience through this challenge. If you have any questions about this process, please feel free to contact a LPMGA Board member, Dan Devenport or Charles Hebert with any questions. We will get through this together

2020 Volunteer Hours Update: Please Note Changes

With the current level of uncertainty that surrounds us pertaining to the COVID-19 pandemic and reopening efforts, the LMG State Office is altering the guidelines for LMG certification (2019 trainees) and recertification (active LMG volunteers). The following sections address the changes pertaining to the two separate groups.

For 2019 LMG class trainees who have not yet completed the initial 40 volunteer hours:

The time frame for attaining certification is extended until 2021.

Certification is a two-phase process – classroom training and the initial 40 volunteer hours. Traditionally, trainees have one year to become a certified LMG volunteer.

For 2019 trainees, this time frame would have ended in 2020, but has been extended for one full calendar year.

Since trainings start and end throughout the year, please submit clarification questions regarding the specific time frame extension with your local LMG coordinator.

For 2019 LMG class trainees who have completed their 40 volunteer hours:

You are now recognized as a "certified" LMG volunteer. You are not required to report any additional hours for the 2020 calendar year. However, reporting all volunteer time, including extra time, is graciously appreciated. Individuals in this category will begin working on their recertification hours in 2021.

For certified LMG volunteers, the total number of hours for this year has been reduced based on discussion with other Extension MG coordinators. Instead of 26 hours (20 volunteer service and 6 continuing education), the new total is 20 hours in any combination. This can be 20 hours of continuing education or a mix of volunteer service and continuing education.

So, what are some ways you can earn these hours given the COVID-19 pandemic?

Continuing Education – Computer Based:

Horticulture webinars (I have been sharing options on the LMG webpage as I learn about them)

A short word of caution is to take information presented from other parts of the country with a grain of salt. We may not share the same growing seasons or plant material, so please be mindful.

Viewing Horticulture Hints, local LMG association newsletters, etc. electronically

Continuing Education - No Electronics Needed!

Reviewing information in LMG Handbook and LSU AgCenter to learn more about a particular topic

Reviewing horticulture books, magazine articles, newsletter and newspaper articles, and other reference materials.

Volunteer Service Hours Already Earned:

Remember, any volunteer service hours completed prior to the pandemic should be counted. This includes:

Preparing for Horticulture Seminars and Gardening Workshops

Preparation for plant sales (planting seeds, propagation efforts during this calendar year, etc.)

Plant Sales (a few associations were able to host their sale prior to the government shutdown)

Technology-based Volunteer Service Opportunities:

Compiling research and information on a horticulture topic and assembling that information into a presentation or newsletter article to be given at a later date.

This could stem from a webinar you viewed. If you think other MGs would benefit from the information, write up a summary of the webinar.

Virtual LMG meetings with educational topic included

Virtual horticulture-related or LSU AgCenter advisory committees

Virtual community advisory committees (representing local LMG program).

Creating horticulture garden and how-to videos and posting on local LMG Facebook Page

Creating horticulture videos and posting to YouTube for sharing on LSU AgCenter webpage and Facebook page for local Extension office (this will require coordination between several individuals).

Volunteer Service Opportunities Without Using Technology:

Current LMG projects are approved as of the latest Louisiana Master Gardener Coronavirus Guideline Update (June 4, 2020)

Compiling research and information from print materials to assemble presentation or newsletter article

Propagating plant material for upcoming plant sale (fall or next spring)

Caring for current plant sale inventory until sale can safely be held.

REDUCTION IN REQUIRED HOURS FOR 2020 AND VOLUNTEER/CE OPPORTUNITIES Twenty Is Plenty

FOR MEMBERS WHO ARE CURRENTLY ACTIVE:

To remain Active in 2021, you will need to record a total of 20 hours in 2020.

These 20 hours can be any combination of Volunteer and CE, or can be 20 CE OR 20 Volunteer hours.

The additional requirements of paying annual dues for 2021 and signing and submitting the Code Of Conduct will still apply.

FOR MEMBERS WHO HAVE BEEN INACTIVE IN 2020:

To return to Active status for 2021 you will need to record a total of 20 hours in 2020.

These 20 hours can be <u>any combination</u> of Volunteer and CE hours,
or can be 20 CE <u>OR</u> 20 Volunteer hours.

The additional requirements of paying annual dues for 2021 and signing and submitting the Code Of Conduct will still apply.

FOR 2019 MASTER GARDENER CLASS MEMBERS:

To meet the state requirement to become a Certified Master Gardener, you will still have to record 40 hours of Volunteer work. However, you will have an additional year (2020 plus 2021) to perform these hours. You will retain any volunteer hours you recorded in 2019, any you record in 2020 and have until December 31st of 2021 to achieve the 40 hour total.

If you have already achieved and recorded your 40 hours...

Congratulations, you are now a Certified Louisiana Master Gardener.
In 2021, you will begin to record 20 Volunteer hours and 6 Continuing Education hours to remain Active. In 2021 the additional requirements of paying annual dues and signing and submitting the Code Of Conduct will apply.
